VENDOR INFORMATION

Shelby Humane Society cordially invites you and to participate in our Pitty Party on Saturday, June 18, 2022, beginning at 11:00am. The Pitty Party will celebrate the bond between people and their pets with a great day full of music, vendors, food, and children's activities.

We hope you will plan to join us for this exciting event! Please read the following guidelines carefully and complete the enclosed application. Applications are **due by June 3**, **2022**. Applications will be considered on first come, first served basis.

VENDORS MUST OBSERVE THE FOLLOWING RULES:

- 1. All vendors must provide a copy of their business license along with this application.
- 2. Any tent or shelter must be free standing as it may be placed on concrete sidewalks, grass, or asphalt.
- 3. Vendors must furnish tents and tables used.
- 4. Vendors may set up Saturday morning starting at 9:00am, completing set-up by 10:15am. All vehicles must be out of the vending area by 10:30am. Vendors are required to bring their own tents and tables if needed.
- 5. Each exhibitor is responsible for his/her own display. Spaces are approximately 15 x 11 and may/or may not be level.
- 6. Reservation deadline is June 3rd. Shelby Humane reserves the right to refuse any vendor application.
- 7. Booth assignments will be available the day of the event at the site. However, we will try to have this information available prior to the event.
- 8. The Shelby Humane logo, Name and that of any artist performing at Shelby Humane may not be used without authorization.
- 9. Shelby Humane reserves the right to refuse any Vendor/Organization's entry into the festival.
- 10. Business conducted within a vendor space must be limited to the company or individual assigned to that location. All vendors must limit their business to the space they are provided and may not distribute information or goods outside of their assigned space.
