The organization identified herein and its officers, agents, directors, shareholders, employees, volunteers, fosters, successors and assigns (“Releasors”) do hereby forever release, discharge and save harmless The Humane Society of Shelby County (“Shelby Humane”) its officers, agents, directors, shareholders employees, successors and assigns (“Released Parties”) of and from all liability, claims, actions, losses, costs, damage, expenses, injuries, demands or any other claims whatsoever, for damage to property or physical, mental or emotional injury, at any time and in any manner arising, in whole or in part, directly or indirectly, out of or relating to any animal removed from Shelby Humane custody by the organization. In addition, Releasors do hereby agree to indemnify and hold the Released Party harmless of any liability, claims, actions, losses, costs, damage, expenses, injuries, demands or any other claims whatsoever, asserted by any other person against Released Parties, at any time and in any manner arising, in whole or in part, directly or indirectly, out of related to any animal removed from Shelby Humane custody by the Organization.

Both organizations agree they have a mutual responsibility not to act in a way that is likely to damage trust, cause serious offence, or bring either organization into disrepute via social media or other public media channels.

Examples include:

- a. Making seriously offensive, derogatory or defamatory remarks;
- b. Bullying, intimidating or harassing others;
- c. Posting comments or material which are hateful, libelous, slanderous, threatening, extremist, discriminatory or of an overtly sexual nature;
- d. Posting of inappropriate images and/or videos of Shelby Humane facilities, staff, animals, volunteers, or visitors.
- e. Undermining confidence in the organization;
- f. Words or Actions which harm the reputation of the organization.

Both Releasors and Released Parties agree that they will not reveal confidential information about the other organization, or its staff, officers, or volunteers. This might include aspects of confidentially protected organization policy or internal discussions, intake details on an animal, treatment of animal, information relating to policies of the organization, animal data, animal outcomes, or any other organization protected information.
